

The EC noted the contents of DoPT OM No. F. No. Misc-14017/15/2015-Estt. (RR), dated 11.01.2016 received through UGC communication letter dated 16.10.2017 regarding the method of recruitment in Central Ministries/Departments (Autonomous Bodies /PSUs / Statutory Bodes) according to which, the entire selection process (from release of advertisement, conducting of Written Test/Interview etc.) is to be completed within six months from the date of advertisement.

64.3(19) Enhancement of age of superannuation of Medical Doctors working in the Central Universities (other than Central Health Service Doctors) to 65 years

The EC considered and adopted the instruction issued by the MHRD and M/o Health & F.W. vide letter No.F.No. 65-7/2016-Desk (U), dated 01.11.2017 and O.M. No. A.12034/1/2017-CHS-V dated 30.09.2017 respectively regarding enhancement of age of superannuation of the Medical Doctors to 65 years other than Central Health Service by the Govt. of India. Accordingly, the age of retirement of Medical Officers in MANUU shall be 65 years and amendment in the service rules wherever necessary will be processed.

64.3(20) Appointment of Dr Afroz Alam, Associate Professor, Department of Political Science as Professor-cum-Director, In-charge, ACSSEIP

The Executive Council ratified the action taken for appointment of Dr. Afroz Alam, Associate Professor, Dept. of Political Science as Incharge Professor-cum-Director of Al Beruni Centre for the Study of Social Exclusion and Inclusive Policy (ACSSEIP) w.e.f. 04.10.2017 (AN) until further orders vice Prof.Kancha Ilaiah on his attaining the age of 65 years.

64.3(24) Appointment of Guest Faculty in DDE as per UGC (ODL) Regulations - 2017

The Executive Council was informed that the UGC (ODL) Regulations, 2017 were adopted by the Academic Council in its 27th Meeting held on 05.09.2017. According to clause 6 & Annexure-VI of the said Regulations, it becomes mandatory on the part of every dual mode University to have at least two full time faculty members, dedicated to Open and Distance Learning (ODL) courses) per discipline or specialization or programme at Associate and Assistant Professor level.

In the past, the UGC had sanctioned teaching and non-teaching posts for the DDE, MANUU from time to time and these posts were already filled. As per the Notice released by the UGC vide letter No. 74-4/2017 (DEB-4) dated 29th June 2017, all Higher Educational Institutions (HEIs) have been permitted to offer ODL programmes for the current academic year 2017-18. Such HEIs are required to apply afresh in the prescribed format as per the UGC (ODL) Regulations, 2017 for consideration of recognition/approval of the courses.

In order to fulfill the above requirements under the UGC (ODL) Regualtions-2017 notified by the UGC on 23rd June 2017, the Academic Council approved the proposal of the Director, DDE to engage Guest Faculty till the sanction of additional faculty posts as per revised norms introduced by the UGC.

Accordingly, the following Guest Faculty were engaged by the DDE by holding walk-in-interview after open advertisement through Newspapers and the University's website to the extant of short-fall for the existing distance education courses being offered by the DDE. The appointment of Guest Faculty was, initially for a period of 6 months on a consolidated salary of Rs.25,000/- per month. The following 18 Guest Faculty, who were appointed by the University through walk-in-interview, have joined duties in DDE:-

The EC further noted that as per the approval accorded by the UGC, the above sanctioned teaching posts for Polytechnics at Kadappa and Cuttack are meant initially for the first year for those courses to be started from the academic year 2018-19. Additional teaching positions will be considered by the UGC as per AICTE norms at a later stage after reviewing the functioning of the campus.

(D) Director In-charge/Officer-on-Special Duty (OSD) - 2 posts (one each for Kadappa and Cuttack)

EC noted the sanction of two posts of Director In-charge / OSD, one each by the UGC for Kadappa and Cuttack Campuses, to be filled on contract /tenure basis for the overall supervision / liaison with the State Govt. and other regulatory authorities with regard to development of the campus (Polytechnic / ITI) for a period of three years or till the completion of the Project whichever is earlier on a consolidated Fee/emoluments which shall not exceed the total emolument of a Professor. EC was updated on the status of filling up these positions.

(E) Security Staff at Kadappa & Cuttack campuses:

EC further noted that as per the UGC approval, the University may also make the provision of the Security through outsourcing agency on need basis from the Recurring Head of accounts.

64.3(26) Continuance of UGC Schemes beyond 30.09.2017

The Executive Council was informed that the UGC communication No. F.1-8/2016 (JS/F/CPP-II), dated 18th October 2017 in which it has been informed that UGC schemes in rationalized form will continue beyond 30.09.2017 and upto 31.03.2019 and, in turn, a Notification No. MANUU/P&D/F.104/2017-18/69, dated 13th November 2017 has already been issued by the University.

The Executive Council noted the same.

64.3 (27) Appointment of Prof. Mohd. Akbar Ali Khan, DDE as Additional Director, DDE

The Executive Council noted and ratified the action taken by the Vice-Chancellor in appointing Prof. Mohd. Akbar Ali Khan, as Additional Director, Directorate of Distance Education w.e.f. 14.09.2017.

64.3 (28) Reviewing the functioning of all the Centres /Campus /Constituent Units under the umbrella of MANUU

The Executive Council noted the communication No. 48-3/2017 (CU), dated 16th October 2017 received from the UGC regarding review of functioning of all the Centres/Campus/Constituent Units under the umbrella of MANUU for proper utilization of infrastructure.

One of the members appreciated the efforts made by the University for undertaking the academic review of one of the Centres namely H. K. Sherwani Centre for Deccan Studies by external experts and suggested that a similar exercise is required for other Centres/Units/Campuses. Meanwhile, the Members concerned suggested that a status report on each such Centres/Campus/Constituent unit may be prepared and presented to the EC through power point presentation.

64. 4: Items for Consideration

64.4(1) Minutes of the 28th Academic Council (Emergent) meeting held on 05.09.2017

The Executive Council approved the Minutes of the 28th meeting of the Academic Council held on 05.09.2017.

64.4(2) Annual Report of the University for the Year 2016-17

The Executive Council approved the Annual Report of the University for the Year 2016-17.

64.4(3) Meeting of the 34th Finance Committee

The Executive Council approved Minutes of 34th Finance Committee meeting held on 19.11.2017.

64.4(4) Annual Accounts of the University for the Year 2016-17

The Executive Council approved the Audited Annual Accounts of the University for the year 2016-2017 and **resolved** to submit the same to the Government of India, MHRD to be laid in both the Houses of the Parliament as per the requirements under Section 30 of the University Act.

64.4(5) Recommendations of the Committee constituted for revision/framing of Recruitment Rules (RRs) for various Non-Teaching posts (including Library & Physical Education) in MANUU

The Executive Council was informed that in compliance with the instructions issued by the UGC vide letter No. F. No. 69-4/2012 dated 14th August 2015, the University had constituted a Committee with external experts to review the existing Recruitment Rules (RRs) for Non-Teaching posts including Library and Physical Education & Sports posts vide Notification dated 13.12.2016.

The EC noted that the promotion to the post of Assistant Registrar against 50% quota is done through three feeder grades namely Section Officer and Private Secretaries/Assistant Account Officers with five years of regular service. In order to provide equal opportunities to the eligible candidates from three different categories of posts, the EC resolved that the promotion to the post of Assistant Registrar shall be through Limited Department Test and interview as prevalent in other Central Universities.

After discussions, the Executive Council **resolved** to approve the recommendations of the draft Recruitment Rules (RRs) with Schedule, indicating minimum qualifications, experience, age limit etc in respect of 75 categories of non-teaching posts including Library and Physical Education & Sports in the University and Appendix related to composition of Selection Committees for various posts included in the Schedule.

The EC also **resolved** to frame a revised Ordinance in place of existing Ordinance 3 of the Ordinances of the University related to '*Rules and Procedure for appointment to the non-teaching posts*' published in the Official Gazette of India (Part-III- Section 4), dated 17th July 2004 by the University through MHRD vide Notification F.No. 27-12/2000-Desk (U), dated 5th August 2003.

Accordingly, the EC further **resolved** that the revised Ordinance-3 'The *Maulana Azad National Urdu University Cadre Recruitment (Non-Teaching Employees including Library and Physical Education) Rules, 2017* be sent to the MHRD for necessary publication of the same in the Official Gazette of India as required under Section 43 (1) of the University Act.

- 64.4(6) Letter received from the Commissioner Greater Hyderabad Municipal Corporation (GHMC) for handing over the affected portion of land under proposed 30 Mts and 18 mts road towards southern side of the compound wall of the MANUU Campus, Gachibowli, Hyderabad for development purpose
 - 1. It was brought to the notice of the EC that the Commissioner, Greater Hyderabad Municipal Corporation (GHMC) vide his letter No. 2410/RW/TPS/HO/GHMC/2017/1216 dated 02.11.2017 had informed that as per the planning under the Cyberabad Development Authority

- (CDA) of GHMC Master Plan, there are 8 roads passing through the middle of the premises of Maulana Azad National Urdu University (Urdu University) and the same is dividing into 8 portions. It was stated that the matter was discussed with the Hon'ble Municipal Minister and it was decided to realign the Master Plan road all along the Eastern Southern and Western side of the Boundary of the MANUU, Gachibowli Campus with 30 mts & 18 mts width so as to avoid division of the land of University into 8 portions. The proposed roads are getting affected to an extent of (South & East + West) i.e. 83,928 sq.mts instead of 8 roads area 1,42,852 sq.mts duly deleting the 8 proposed roads passing through the University land under the CDA Master Plan. In view of the above, the Commissioner, GHMC has requested the University to handover the affected portion under proposed 30 mts & 18 mts roads as per sketch plan enclosed, as early as possible.
- 2. The Registrar informed the EC that as against the initial commitment of 500 acres of land by the then Government of A.P., only 200 acres of land (Survey No. 211 & 212) was allotted to the University at Gachibowli (Rajendra Nagar Mandal Manikonda Village) by the Revenue Department, Government of Andhra Pradesh vide Memo No. 79815/Assn.V(2)/96-8, dated 18.3.1998. Later on, 53 acres of land in excess of 200 acres (Survey No. 211 & 212) earlier allotted by the Govt. of A.P to the University was taken back vide order dated 7.5.2003 by the Government of A.P. The University had challenged the said order through Civil Writ Petition No. 9617 of 2003 and a stay was granted to the University. But the Court had allowed the then Government of A.P. to recover the excess land of 53 acres from the University vide order dated 8th January 2004.
- 3. He further informed that the matter regarding any transfer of land belonging to Government of India including its statutory & Autonomous bodies are covered under Rule 310 (2) of the General Financial Rules (GFR), 2017 and, according to which, transfer can be done on the basis of mutually agreeable terms and conditions or in exchange for equal land value land or payment of value of land or cost of acquisition.
- 4. After discussing the matter at length, the EC felt that the proposed link road from the Old Bombay Highway to ORR along the periphery of ESCI and MANUU premises on the bank of *Khajaguda Talab* would create a second approach road for the University.
- 5. In view of the above, the EC **resolved** that the University may communicate its willingness to the Commissioner, GHMC for the transfer of affected portion of land on Khajaguda Talab (Cheruvu) side (Southern side of all along the compound wall of MANUU premises) for the proposed Link road between *Old Bombay Highway* to ORR via ESCI premises for development purpose to the Greater Hyderabad Municipal Corporation (GHMC) subject to the condition that alternate land of equal value adjacent to the Gachibowli campus shall be

provided by the Govt. of Telangana in conformity with the Rule 310 of GFR, 2017.

6. The EC also felt that there should be a revised Master Plan for the University Campus at Gachibowli for future development.

64.4(7) Extension of tenure of Dr. K. P. Singh. Finance Officer on reemployment basis

The EC approved the extension of tenure of Dr.K.P.Singh as Finance Officer on re-employed basis, for another period of one year w.e.f 1.12.2017, on the existing terms and conditions as applicable to re-employed pensioners.

64.4 (8) Recommendations of the selection committees

The Executive Council approved the recommendations of the Selection Committees for the appointment of the following candidates against the vacant posts notified in Employment Notification No.45/2017 dated 12.09.2017 and No.Nil dated 18.10.2017

64.5 Any other item with the permission of the Chair.

64.5(1) Creation of the post of Dean (Alumni) in the University

The Executive Council considered and approved the proposal for creation of Dean (Alumni) in MANUU on honorary basis.

64.5(2) Constitution of the First Court of the University

The EC noted that according the Section 42 (d) of the MANUU Act, 1996, the First Court shall consist of not more than thirty members who shall be

nominated by the Visitor and they shall hold office for a term of three years. However, the First Court of the University is yet to be constituted by the office of the Visitor.

The Registrar presented the details of the relevant statutory provisions of University Court as per MANUU Act vis-a-vis the Central University Act, 2009 and the same was noted by the EC.

Keeping in view of the statutory requirements under the MANUU Act and similar provisions in the Central Universities Act, 2009, the Executive Council unanimously **resolved** to approve the amendment to the existing Statute 11, regarding the constitution of University Court as under:-

Existing Statute 11

The Court-

Ten members of the Court shall form a quorum for a meeting of the Court

Amendment approved to the existing Statute 11:

Statue 11:

The Court-

(1) The Court shall consist of the following persons namely:-

Ex-officio members:-

i. The Chancellor

(ex officio Chairperson)

- ii. The Vice-Chancellor
- iii. The Pro-Vice-Chancellor
- iv. All Deans of Schools of Studies
- v. The Registrar

(ex-officio Member Secretary)

- vi. Proctor
- vii. Director, DDE

viii. Representatives of Heads of Departments:

Four persons from amongst the Heads of Departments who are not Deans of Schools of Studies, by rotation according to seniority.

- xi. Professors/Associate Professors/Assistant Professors who are not Deans of Schools of Studies and Head of Departments and Principals of Constituent Institutions in the following manner:-
- (a) *Two Professors*, by rotation according to seniority from amongst the University Departments/Directorate of Distance Education/Centres/Constituent Colleges/Institutions;
- (b) Two Associate Professors, by rotation according to seniority from amongst the University Departments/ Directorate of Distance Education /Centres/Constituent Colleges/ Institutions;

- (c) Four Assistant Professors, by rotation according to seniority from amongst the University Departments/Directorate of Distance Education/ Centres/Constituent Colleges/ Institutions; and
- (d) One Principal of the Polytechnic, by rotation according to seniority.

x. Nominated members:

Four persons of distinction in academic or public life, not in the services of the University, and have contributed significantly for the promotion of Urdu language to be nominated by the Visitor.

- (2) All the members of the Court, other than the *ex-officio* members, shall hold office for a period of *three years*.
- (3) An annual meeting of the Court shall be held on a date to be fixed by the Executive Council unless some other date has been fixed by the Court in respect of any year.
- (4) At an annual meeting of the Court, a report on the working of the University during the previous year, together with a statement of the receipts and expenditure, the balance-sheet as audited, and financial estimates for the next year shall be presented.
- (5) A copy of the statement of receipts and expenditure, the balance-sheet and the financial estimates referred to in clause (2) shall be sent to every member of the Court at least seven days before the date of the annual meeting.
- (6) The Chancellor shall preside over the meetings of the Court. In the absence of the Chancellor, the Vice-Chancellor shall preside over the meetings of the Court.
- (7) Special meetings of the Court may be convened by the Executive Council or the Vice-Chancellor or if there is no Vice-Chancellor, the Pro-Vice-Chancellor or if there is no Pro-Vice-Chancellor, by the Registrar.
- (8) Ten members of the Court shall form a quorum for a meeting of the Court.

The EC further **resolved** to send the amended Statute to the office of the Visitor for his assent as required under Section 26(3) of the University Act through MHRD.

64.5(3) Cases of reinstatement of Mr. Satya Sai Kumar A (WP No. 37714 of 2013), Dr Kahkashan Tabassum (WP No. 36581/2013) and Mr. Abdul Saifullah (WP No. 38240 of 2013) former Assistant Professors, Department of CS & IT, MANUU as per the common order dated 22.09.2017 passed by the Hon'ble High Court of Telangana & A.P

64.5(5) Nominations for the appointment of new Chancellor

The Executive Council noted that the tenure of present Chancellor, Mr. Zafar Sareshwala would be ending on 31.12.2017. The EC also authorized the Vice-Chancellor to send the above panel of three names to the Visitor.

64.5(6) Report of the Enquiry Committee constituted by the Vice- Chancellor to look into the installation and purchases of Wi-fi, Wi-Max, University website and Printing of SIM through Manipal Press etc.

64.5(7) Ratification of the appointment of Inquiry Officer to enquire into the allegations of misconduct against Mr. Mohd. Shaheer Zaman, Assistant Professor-ECE (Under suspension), MANUU Polytechnic, Darbhanga (Bihar)

The EC noted that pursuant to the decision taken by the EC in its previous meeting held on 07.09.2017, Mr.Mohd.Shaheer Zaman, Assistant Professor-ECE, MANUU Polytechnic Darbhanga was placed under suspension, pending departmental enquiry under rule 14 of CCS (CCA) Rules. A charge memorandum was issued on 10.10.2017 and Mr. Zaman denied all the three charges levelled against him. As per the CCS (CCA) Rules, an Inquiry Officer is required to be appointed by the competent authority of the University.

The Executive Council noted and ratified the action taken by the Vice-Chancellor in appointing Mr.Justice Ashok Kumar Roopanwal, a retired Judge of Hon'ble High Court of Allahabad as Inquiry Officer to inquire into the article of charges framed against Mr.Mohd.Shaheer Zaman, Assistant Professor-ECE (under suspension), MANUU Polytechnic, Darbhanga.

64.5(8) To report the extension in joining time granted to Dr. S. Kazim Naqvi on appointment as Professor - DDE
